15 - Professional Salaries	ARP will no longer be used to cover the Dir of Summer Academy, Summer Academy Track Leader stipends, and Summer Academy Lead Teacher stipends for a decrease of \$101,970. Stipends for Summer Academy Instructors will be increased by \$11,824 for a new total of \$149,104. Due to staffing changes, the FTES and Project Salaries for the following positions have been decreased for a total decrease of \$188,068: Dean of Culture, Assoc Deans (2); Social Workers (2); Mental Health Case Mgr; Attendance Coord; Dir of Scholar Services; Deans of Instruction - 22-23; ENL Teacher - 22-23; ELA Teacher - 22-23; ENL Teacher - 22-23; and ENL Coord - 22-23. In addition, the following positions will no longer be covered for a total decrease of \$461,980: Mgr of Assessment for Learning; Specialized Classroom Teacher; Deans of Instruction 23-24 (2); Math Teacher 23-23; ELA Teachers 23-24 (2); ENL Teacher 22-23; and ENL Coord 23-24. Due to a change in salaries, the amount of ARP funding to be used for two Assoc Deans and the ELA Teacher 22-23 will be increased by \$4,428. In addition, funding will now be used to partially cover the salaries of the following staff members who are focused on addressing learning loss and meeting the needs of students for a total increase of \$735,767: Social Workers 22-23 (2); Math Teachers 22-23 (8); ELA Teachers 22-23 (6); and ENL Teacher 22-23.
